Joint bid with TÜViT results in four-year master agreement.

Munich, November 12, 2015. In September of 2015, msg and TÜViT won a joint bid with the Federal Ministry of Transport and Digital Infrastructure (BMVI). The results are two four-year master agreements addressing issues surrounding project and requirement management, as well as quality assurance and testing.
